The School Safety Plan includes complete strategies and direction in case of fire, earthquakes, floods, bomb threats, and other possible occurrences. The School Safety Plan was developed with the help of the Lathrop Police Department and Fire Department. Rules and procedures are outlined in the Plan and the staff reviews safety procedures at least annually. The safety plan was approved by the Sheriff and Fire Departments, Parent Advisory Committee, and discussed with the school board and approved in the Fall of 2023. The approved plan was then shared with school faculty and student representatives with no changes needed after review.
